1. Formulas and medical food used solely for the purpose of enhancing nutrient intake or managing body weight (e.g. vitamin, fat, protein, carbohydrate supplements and weight loss products).
2. Hyperalimentation feeding
3. Oral re-hydration fluids or electrolyte solutions (e.g., Pedialyte)
4. Flavoring Agents (e.g., Neocate Jr. flavor packet)
