Similac Sensitive w/ Iron	PWD - 12.5 oz. RTF - 32 oz.		Milk-based infant formula with reduced lactose for infants with lactose sensitivity or intolerance.	
Similac Total Comfort w/ Iron	PWD - 12.6 oz.		A milk-based infant formula that contains partially hydrolyzed protein and reduced lactose for easier digestion.	
Ready to Feed Formulas (RTF) may be authorized when the CPA determines and documents that one of the following conditions are met: 1) The participant's household has an unsanitary or restricted water supply or poor refrigeration, 2) The person caring for the participant may have difficulty in correctly diluting concentrated liquid or powder forms; or 3) The WIC infant formula is only available in ready-to-feed. In addition to those conditions, RTF may be issue in Food Package III if 1) a RTF form better accommodates the participant's condition; or 2) if it improve the participant's compliance in consuming the prescribed WIC formula.				

A WIC-48 Louisiana Medical Request for Formula and/or Food is required for issuance of exempt formulas or WIC-eligible nutritionals.
