Standard Infant Formulas

WIC provides contracted formulas as part of a federally mandated cost containment system. In accordance with federal regulations, all WIC formula fed infants may receive any of the standard contract formulas listed below.

Similac Advance w/ Iron <i>Abbott</i>	PWD - 12.4 oz. CONC - 13 oz. RTF - 32 oz. *	Milk based infants formula, includes DHA, ARA and prebiotics.
Similar Soy Isomil w/Iron <i>Abbott</i>	PWD - 12.4 oz. CONC - 13 oz. RTF - 32 oz. *.	Soy based formula, includes DHA and ARA
Similac Sensitive w/ Iron <i>Abbott</i>	PWD - 12.5 oz. RTF - 32 oz. *	Milk-based infant formula with reduced lactose for infants with lactose sensitivity or intolerance.
Similac Gentle Comfort w/ Iron <i>Abbott</i>	PWD - 12.6 oz.	Partially hydrolyzed whey protein, an alternative to standard intact-protein, milk-based formulas. Suitable for lactose sensitivity; for infants who may have difficulty tolerating other milk-based formulas.
Similac Total Care 360 <i>Abbott</i>	RTF 32 oz. * RTF 8 oz. *	Milk-based non-GMO infant formula, containing 5 HMO prebiotics.
Similac Total Care 360 Sensitive <i>Abbott</i>	RTF 32 oz. * RTF 8 oz. *	Milk-based non-GMO infant formula, containing 5 HMO prebiotics. Suitable for infants with lactose sensitivity

* The CPA may approve and issue a RTF **standard contract formula** when one or more of the following conditions are met:

1. Unsanitary/restricted water supply,
2. Poor refrigeration
3. The participant's caregiver is cognitively/physically unable to correctly dilute concentrated liquid or powdered formula.

Exempt Infant Formulas

A WIC participant may have a medical condition and need medical formulas that are not part of a WIC formula contract. Health Care Providers must provide a WIC 48 or a medical prescription when requesting WIC-eligible infant formulas for their patients that have a qualifying medical condition.

Similac Special Care 24 cal. <i>Abbott</i>	RTF - 2 oz.	A 24 Cal/fl oz. iron-fortified formula for growing, low-birth-weight and premature infants. Not intended for feeding low-birth-weight infants after they reach a weight of 3600 g (approximately 8 lb.) or as directed by a physician
Similac Special Care 24 cal. High Protein <i>Abbott</i>	RTF - 2 oz.	A 24 Cal/fl oz. iron-fortified premature infant formula for low-birth-weight infants who may need extra protein to help support growth. Not intended for feeding low-birth-weight infants after they reach a weight of 3600 g (approximately 8 lb.) or as directed by a physician
Similac Special Care 30 <i>Abbott</i>	RTF - 2 oz.	A 30cal/oz. infant formula for premature or low-birth weight infants. Not intended for feeding low-birth-weight infants after they reach a weight of 3600 g (approximately 8 lb.) or as directed by a physician
Enfamil Premature 20 cal. <i>Mead Johnson</i>	RTF - 2 oz.	Milk-based infant formula with 20 Calories/fl oz. for premature or low birth weight infants who are not being breastfed. When more than 14 fl oz. is used per day, some nutrients may be excessive. In such circumstances, it should be used only at the direction and under the supervision of a doctor.
Enfamil Premature 24 cal. <i>Mead Johnson</i>	RTF - 2 oz.	For the management of premature and low birth weight infants. When more than 12 fl oz. is used per day, some nutrients may be excessive. In such circumstances, it should be used only at the direction and under the supervision of a doctor.

Similac Neosure <i>Abbott</i>	RTF - 2 oz. PWD - 13.1 oz.	A 22-calorie formula designed for babies who were born prematurely to be used as a preterm post-discharge formula.
Enfamil Neuropro Enfacare <i>Mead Johnson</i>	RTF - 2 oz. PWD - 13.6 oz.	A 22 calorie/ounce formula post discharge formula for infants who were born prematurely or with low birth weights.

Exempt Infant Formulas

A WIC participant may have a medical condition and need medical formulas that are not part of a WIC formula contract. Health Care Providers must provide a WIC 48 or a medical prescription when requesting WIC-eligible infant formulas for their patients that have a qualifying medical condition.

Nutramigen with probiotic/LGG <i>Mead Johnson</i>	PWD - 12.6 oz.	20 Cal/fl oz., lactose-free, hypoallergenic infant formula designed for infants who have food allergies including cow's milk allergy. Contains has extensively hydrolyzed casein protein to help avoid an immune system response by reducing the allergen exposure, and the probiotic branded LGG to help support the strength of the intestinal barrier and support digestive health.
Nutramigen (liquids) <i>Mead Johnson</i>	CONC - 13 oz. RTF - 32 oz.	20 Cal/fl oz., hypoallergenic infant formula designed for infants who are allergic to the intact proteins in cow's milk and soy formulas. Contains extensively hydrolyzed casein protein to help avoid an immune response by reducing the allergen exposure and is proven effective for managing colic due to cow's milk allergy.
Similac Alimentum <i>Abbott</i>	RTF - 2 oz. RTF -32 oz. PWD - 12.1 oz.	A 20 Cal/fl oz., hypoallergenic formula for infants, including those with colic symptoms due to cow's milk protein sensitivity, food allergies, or sensitivity to intact protein. RTF formula is corn free.
Extensive HA <i>Nestle</i>	PWD - 14.1 oz.	Hypoallergenic, whey protein extensively hydrolyzed formula for infants who are sensitive to intact protein in milk based formulas contains probiotics; B. lactis. Indicated for cow's milk protein allergy, and intolerance, (FPIES), soy protein sensitivity, and fat malabsorption.
Pepticate Infant <i>Nutricia</i>	PWD 13.2 oz.	A 20 Cal/fl oz., whey-based hypoallergenic, extensively hydrolyzed formula for infants, contains DHA, ARA, nucleotides, lactose and a clinically tested blend of prebiotic fibers.

PurAmino DHA/ARA <i>Mead Johnson</i>	PWD - 14.1 oz.	Hypoallergenic, amino acid-based infant formula for the dietary management of infants with severe cow's milk protein allergy, not effectively managed by an extensively hydrolyzed formula. Also for infants with multiple food protein allergies. It may also be suitable for conditions requiring an elemental diet such as protein maldigestion, malabsorption, short bowel syndrome and eosinophilic esophagitis.
EleCare Infant DHA/ARA <i>Abbott</i>	PWD - 14.1 oz.	Hypoallergenic, amino acid-based formula for infants who cannot tolerate intact or hydrolyzed protein, protein maldigestion, malabsorption, severe food allergies, short-bowel syndrome, eosinophilic GI disorders, GI-tract impairment, or other conditions in which an amino acid based diet is required.
Neocate Infant <i>Nutricia</i>	PWD - 14.1 oz.	Hypoallergenic, amino acid-based infant formula with DHA and ARA, for the management of cow milk allergy, multiple food allergies and related GI conditions.

Enfaport <i>Mead Johnson</i>	RTF 6 oz.	A 30 calorie/fl oz., milk-based formula for infants with chylothorax or LCHAD. Product has a 60:40 whey: casein protein blend.
Pregestimil 24 cal. <i>Mead Johnson</i>	RTF - 8 oz.	A 24 calorie/fl oz. hypoallergenic formula with MCT, for infants who experience fat malabsorption and who may also be sensitive to intact proteins.
Enfamil 24 <i>Mead Johnson</i>	RTF -2 oz.	24 Cal/fl oz. milk based formula for full term infants that require increased caloric density.
